RE: RENEWAL NOTICE TO ALL MEDICAL AND DENTAL PRACTITIONERS FOR THE YEAR 2024

This is to notify you that the online renewal of practice licenses for doctors and health institutions is now open. You are therefore required to renew your 2024 practice licenses by **31st December 2023**

1) RENEWALS

A. ALL PRACTITIONERS (MEDICAL, DENTAL AND COMMUNITY ORAL HEALTH) - PRACTICE FEES FOR THE YEAR 2024

All medical and dental practitioners are required to access the online services portal from <https://osp.kmpdc.go.ke>. Create Account using **Your KMPDC Registration Number (e.g. A0000 or B0000, C0000, D0000, E0000)** together with National ID Number or Passport Number or Login using your username and password if you had already created an account.

N/B: All new doctors without OSP/ICPD accounts are required to omit any 0's preceding their registration number (e.g. Instead of A0015000, write A15000, Instead of B015000, write B15000, C015000, write C15000, D015000, write D15000, E015000, write E15000)

B. PRACTICE LICENCES

a) Kenyan

i. General Practice License	Kshs 10,000.00
ii. Registrar Practice License	Kshs 10,000.00

iv. Specialist Practice License	Kshs 20,000.00

b) Non Kenyans (East African Region)

i) General Practice License	Kshs 35,000.00
ii) Specialist Practice License	Kshs 45,000.00

c) Non Kenyans (Temporary License) License Fees Kshs 20,000.00

d) Community Oral Health - Kshs. 8,000.00

2) MODE OF PAYMENT

Payments are made against a **unique system generated invoice** issued upon making a successful application for Practice License Renewal.

3) RECEIVING OF THE PRACTICE LICENSE

Upon successful payment process and **automatic approval**, you will receive an SMS and an email notifying you that the license is ready and can login into your portal download and print your license.

4) CPD COMPLIANCE

You are required to ensure that you have attained the minimum **50 CPD** points on www.icpdkenya.org since CPD compliance is a pre-requisite as you apply for your practice license.

5) INDEMNITY COVER

You are required to ensure that you upload a **VALID INDEMNITY COVER** which is a mandatory document required for you to apply for your practice license. Failure to upload a valid Indemnity Cover shall lead to invocation of Provisions of Cap. 253, Laws of Kenya
