RE: RENEWAL NOTICE TO ALL MEDICAL AND DENTAL PRACTITIONERS FOR THE YEAR 2025

The Kenya Medical Practitioners and Dentists Council is a Body corporate established under Section 3 of the Medical Practitioners – and Dentists Act (CAP 253 of the Laws of Kenya) with the mandate to regulate professional training and practice of Medicine, Dentistry and Community Oral health within the Republic of Kenya. This is to notify you that the Online Portal for the renewal of annual practice licences for all practitioners is now **OPEN**. You are therefore required to renew your **2025** licence before **31st December 2024**. The online portal can be accessed through <https://osp.kmpdc.go.ke>.

1) RENEWALS

All practitioners registered by KMPDC are required by CAP 253, Laws of Kenya to renew their practice license annually within the stipulated period. Failure to renew your annual practice license within this period will result in penalties. Further note that Sec 22 of the Act criminalizes the practice of medicine and dentistry in Kenya without a valid license.

2) REQUIREMENTS

The following are the mandatory requirements for renewal of a practitioner's practice license:

NO	REQUIREMENTS	DESCRIPTION
a.	Good Standing	Only practitioners who are of GOOD standing with KMPDC will be allowed to renew their annual practice license.
b.	CPD Compliance	All practitioners are required to satisfy the Council's requirement of 50 CPD points before renewing their license. (Practitioners can manage and track their CPD points via www.icpdkenya.org)

NO	REQUIREMENTS	DESCRIPTION
c.	Indemnity Cover	Sec 15A of the Act provides that ALL practitioners must in each year take a professional indemnity cover. A VALID professional Indemnity cover is therefore a mandatory requirement for renewal of the annual license.
d.	Payment	Payments for the annual practice license are system generated and done on E-Citizen linked to the practitioner's portal. This is done via: Lipa na Mpesa-Pay bill Business Number – 222222 Account Number: - Unique system generated invoice Enter the amount: - generated by the system <i>(For guidance on the practice license fees for various license categories, please see overleaf)</i>

4) RECEIVING THE PRACTICE LICENCE

Upon successful payment and **automatic approval**, you will receive an email notifying you that the license is ready. You can then proceed to log into your portal, download and print your license.
